



# K-12 Funding for Student Safety Through STOP School Violence Grants

K-12 school districts can receive up to \$1 million to help fund applicable Linewize solutions through the Student, Teachers, and Officers Preventing (STOP) School Violence Program.

#### Administered by:

Bureau of Justice Assistance (BJA)

#### Focus:

Preventing school violence, supporting early intervention, and improving safety

#### Who is eligible?

Independent school districts, private K-12 schools, private charter schools, public charter schools

#### Deadlines:

October 27, 2025: Submit SF-424 via Grants.gov November 3, 2025: Submit application via JustGrants

#### Funding amount:

Up to \$1 million over 36 months
